

### District Announces Funding for Great Streets Small Business Grants

Small businesses on Wisconsin Avenue are eligible to apply for up to \$50,000 in grant funding from the District government for renovations and improvements to strengthen their businesses. Wisconsin Avenue is among the commercial corridors supported by the [Great Streets Small Business Grants](#), funded through the office of the Deputy Mayor for Planning and Economic Development (DMPED). The fiscal year 2017 funding opportunity was announced on August 12.

Small businesses, with annual revenues of less than \$1 million, can apply for capital improvement grants for interior and exterior renovations and/or operational improvements. Great Streets grant funding can be used for: construction, renovations, façade improvements, equipment upgrades, and some soft costs, including marketing, point-of-sale inventory management systems, and business consultation services.

DMPED will join the Tenleytown Business Roundtable on Wednesday, September 14 at 10:00 a.m. to provide an overview of the program. Tenleytown Main Street will also host DMPED in our offices on September 14, from 11 a.m. to 5 p.m., for one-on-one consultations with businesses interested in learning more about the program and how to apply.
